TOPIC – TRAFFIC REGULATION ORDER PROGRAMME 2011/12

SUMMARY

- Traffic Regulation Order (TRO) work forms only a part of the work covered by the Traffic and Transport section of Access and Infrastructure Division. Due to staffing and financial resource constraints it is not possible to action all the requests received for amending existing or implementing new TROs. All such requests are recorded and prioritised against criteria including road safety, community support and impact together with the level of available resources.

- There is pressure on Officers to action all requests, however the funding provided by Hampshire County Council under the agency agreement to do traffic management work is only sufficient to action around 20 TROs each year and future funding is likely to be reduced. The Council typically receives in excess of double this number of requests each year and thus there is a need to prioritise the requests to ensure the most needed are dealt with. The remaining requests are kept on the list for future review or for implementation if additional funding becomes available.
- A TRO programme was produced for 2010/11 (Report CAB1971TP refers) which was effective in prioritising schemes and maximising resources. Following on from this all outstanding TRO requests currently with the Council have again been reviewed and a draft programme for 2011/2012 has been produced. See Appendix A.

PROPOSED DECISION

- That the Traffic Regulation Order programme for 2011/12 be approved as detailed in Appendix A to this Decision Notice.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

- All schemes included within the draft programme and other requests received have been assessed against criteria which include road safety, the concerns of the police, Ward Councillors and the Community.

RESOURCE IMPLICATIONS:

- The cost of implementing the traffic regulation orders and associated signs and lining work will be covered by the Traffic Management agreement with Hampshire County Council or through developer contributions.
