#### **SUMMARY**

The allocation of grants from the Community Chest funding scheme from the approved budget. Grants to organisations which are active in areas covered by the Housing and Communities Portfolio have been discussed with the Portfolio holder and the proposed decisions met with his agreement.

# PROPOSED DECISION

It is recommended that the following grants be awarded from the Community Chest scheme:

- Kala Chethena Kathakali Troupe £250
   Funding recommended towards the cost of publicising event to Stanmore residents.
- 2. 2<sup>nd</sup> Swanmore Guides £400 Funding recommended towards the purchase of camping equipment.

3. Bishops Waltham & District Twinning Association £350
Funding recommended towards the costs of transport and hospitality in the UK for visiting families from St. Bonnet le Chateau. Must use funding to include a visit to Winchester.

4. Bishops Waltham Museum Trust

£500

Funding recommended towards the cost of damp proofing and insulation of loft area to improve storage facilities.

5. Colour Factory (The)

£500

Funding recommended towards the cost of creating an art garden at "The Lodge" through workshops for the elderly, young single mothers and visually impaired.

6. Friends of King Alfred's Buses

£230

Funding recommended for the purchase of equipment to enable the production of promotional material.

7. Saturday Venture Association

£500

Funding recommended towards the cost of transporting disabled youngsters from Winchester to a bespoke training centre in Havant.

8. St. Luke's Church

£300

Funding recommended towards the cost of the flower festival element of 50<sup>th</sup> Anniversay celebrations in Oliver's Battery.

9. Wickham Summer Playscheme

£347

Funding recommended for the provision of a circus day during the Summer Playscheme to be held in August.

10. Winchester City Penguins Swimming Club

£500

Funding recommended towards the cost of taking 30 swimmers to an Olympic Training Village in Lanzarote for one week in October 2006.

11. Winchester & District Athletic Club

£453

Funding recommended for the purchase of trophies/medals for corporate relay event to highlight fundraising activities towards the provision of an athletics track in Winchester.

# REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Grants from the Community Chest scheme are made three times per year. All applications for grants were considered by the relevant Portfolio Holder who received advice from the Partnership and External Funding Officer and other relevant officers as appropriate. - 4. Wickham Folk Festival (£500) for set up and promotion costs of Wickham Folk Festival.
