SUMMARY

This report recommends the allocation of grants from the Community Chest funding scheme from the approved budget. Grants to organisations which are active in areas covered by the Healthier and More Inclusive Communities Portfolio have been discussed with the Portfolio Holder and the proposed decisions meet with his agreement.

PROPOSED DECISION

Towards a commissioned performance addressing issues on the fear of crime.

Towards a computer to enable an office to be established for the project.

4. Rookesbury Hall

£500

Towards new light-weight tables for use / hire at the Hall.

5. South Wonston Table Tennis Club

£380

Towards adjustable table tennis equipment to assist disabled and young players.

6. Tubbs Hall

£250

Towards new chairs for the refurbished Hall

7. Wickham Summer Playscheme

£250

Towards a drumming workshop during the summer holidays

8. Wickham Surgery Health Visiting Team

£500

Towards establishing a new support group for parents and babies aged under one year.

9. Winchester Gallery

£500

Towards a visual arts programme working with young people from across the City.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Grants from the Community Chest scheme are made quarterly. All applications for grants were considered by the relevant Portfolio holder who received advice from the Partnership and External Funding Officer and the Director of Community Services. The following applications were not approved:
