PROPOSED DECISION

That the following grants be awarded from the Community Chest scheme:

1. Bishops Waltham Guide Association £250
Funding towards disability access improvements to current premises.
2. Denmead War Memorial Hall £250
Funding towards storage facilities for the youth activities taking place at the Hall as problems relating to a lack of storage have been identified.
3. Jubilee Rovers Junior Football Club £265
Funding towards new training equipment for the football club which has over 70 young people involved.
