TOPIC – PROPOSED WAITING RESTRICTIONS PARKWAY, WHITELEY

PROCEDURAL INFORMATION

SUMMARY

- Double yellow are lines are proposed to remove parking from the immediate vicinity of the junctions and accesses to improve visibility for traffic exiting on to Parkway.
- The proposal is in keeping with the Corporate Strategy in its attempt to improve traffic management
- The cost of the proposal will be funded through the Traffic Management Agreement with Hampshire County Council. There will be no additional enforcement costs.
- Because of its scale it is not possible to include a plan of the proposal as an attachment. However, the plan can be viewed by contacting Corinne Hollis (contact details above) with Plan reference number 8101006/001.

PROPOSED ECISION

It is recommended that No Waiting (at any time) be approved in the vicinity of the junctions and accesses on Parkway to prevent obstruction of sightlines and improve road safety.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Concerns have been raised by residents and businesses accessed from Parkway regarding obstructive parking around the junctions and accesses which severely reduces visibility. Continued commercial development on Parkway has more than doubled on-street parking in the last two years and development is continuing. The current parking situation severely restricts visibility for vehicles undertaking turning movements and pedestrians trying to cross Parkway.

An enforceable restriction is necessary to ensure compliance, and although at present parking is not a problem in the evenings or at weekends the use of double yellow lines is thought more appropriate than a single yellow line. This is because there is a higher level of public understanding and therefore compliance with double yellow lines. Double yellow lines also do not require associated signing.

There were no objections received to the public consultation. Consulted Members including the County Member are in agreement with the proposal.
