- It is proposed to extend the existing 'No waiting 8am to 6pm Monday to Saturday' restrictions in Cromwell Road, Winchester due to repeated access problems caused by inconsiderate parking adjacent to number 101 Cromwell Road.

- The proposal is in keeping with the Corporate Strategy in its attempt to improve traffic management and road safety.
- The cost of the proposal will be funded through the Traffic Management Agreement with Hampshire County Council. There will be no additional enforcement costs.
