<u>SUMMARY</u>

- It is proposed to extend the existing 'No waiting 8am to 6pm Monday to Saturday' restrictions in High Street, Winchester be replaced with 'Pay and Display 1 Hour Limited Waiting with No Permit Holders Exemption Monday to Saturday' restrictions in order to maximize on-street parking and to prevent illegal parking on the zebra crossing zig-zags.

- The proposal is in keeping with the Corporate Strategy in its attempt to improve traffic management and road safety.
- The cost of the proposal will be funded through the Traffic Management Agreement with Hampshire County Council. There will be no additional enforcement costs.
