SUMMARY

The Cabinet meeting of 17th December 2003 approved in principle the setting up of the Home Improvement Agency in conjunction with Test Valley Borough Council and East Hants District Council, under the auspices of Hampshire County Council - Supporting People (Report CAB 750, 17 December 2003, refers).

The Home Improvement Agency will provide additional support and assistance to elderly, vulnerable and disabled residents in the respective districts as an essential service within the local authorities private sector housing renewal strategy and the Council's Corporate Strategy - key priority - to promote a healthier, safer and more caring community to ensure that services are provided in ways that best meet the needs of residents, both now and in the future.

A draft contract is currently under discussion and is broadly accepted subject to minor amendments

PROPOSED DECISION

That, the City Secretary and Solicitor be authorised to agree the terms and enter into the contract.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

The joint Home Improvement Agency became operative from 1 January 2005 and adjustments to the draft Contract were made subsequent to this with the close involvement of all parties. It was agreed that each partner local authority scrutinise the detail of the final Contract so that, subject to any agreed changes, this can be approved and signed with as little delay as possible. This will also facilitate the payment of each local authority partner's financial contribution to the Home Improvement Agency for 2004/05 which is £22,000 - Report CAB 750 paragraph 4.2 refers. The Contract is for a three year period expiring on 31 March 2007 and the Council will contribute a similar sum for each year of the Contract.

FURTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED FOLLOWING PUBLICATION OF THE DRAFT PORTFOLIO HOLDER DECISION NOTICE

No alternative representations have been submitted or other alternatives considered as the procedure and progress of the Contract has been in accordance with the requirements of the Hampshire County Council's Supporting Peoples contract provisions.
