SUMMARY

The Engineering and Transport Team (Environment) are responsible for introducing new Traffic Regulation Orders (TRO). Each year the Council receives more requests for new TROs than it can implement and consequently a programme is produced to prioritise resources accordingly.

This decision notice summarises the existing TRO requests on file and recommends the TRO programme for 2016/2017.

PROPOSED DECISION

That the Traffic Regulation Order programme for 2016/2017 be approved as detailed in the attached Appendix.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Traffic Regulation Orders (TROs) form part of the work covered by the Engineering and Transport Team (Environment). Due to staffing and financial resource constraints it is not possible to action all the requests received for amending existing or implementing new TROs. All such requests are recorded and prioritised against criteria primarily relating to road safety, community support and impact together with the level of available resources.

There is an understandable expectation that the Council should be able to action all requests it receives and the attached Appendix shows there are a substantial number of these requests across the District. The funding provided by Hampshire County Council, under the agency agreement to do traffic management work, meant we were able to implement 16 TROs in 2013/14, 20 TROs in 2014/15 and 25 TROs in 2015/16 (current estimate subject to final approvals). The volume of potential work therefore means there is a need to prioritise these requests, as mentioned above, to ensure the most urgently needed are dealt with first.

The remaining requests are kept on the list for future review and implementation if additional resources become available. This is however unlikely in the coming year due to one member of the Engineering & Transport team currently being on maternity leave which will significantly increase the overall workload of the remaining team members.

TRO programmes have been produced every year since 2010/11 and have proved an effective and transparent way of prioritising schemes and maximising the use of limited resources as well as managing the expectations of those making the requests for action to be taken. Following on from this all outstanding TRO requests currently with the Council have again been reviewed against the relevant criteria as noted on the draft programme for 2016/2017. See Appendix.

The TRO programme is in keeping with the Community Strategy in its attempt to provide a high quality environment & safe and strong communities through the introduction of appropriate traffic management measures.

RESOURCE IMPLICATIONS:

The cost of implementing the traffic regulation orders and associated signs and lining work will be covered by the Traffic Management agreement with Hampshire County Council or through developer contributions.
