

2011 Census Headline Facts and Figures Winchester






The 2011 Census population of Winchester is 116,600. The population has increased by 9,400 since 2001, approximately 8.7%.





Between 2001 and 2011 there has been a decrease in the percentage of the working age population from 64.2% to 62.9%. There has been a particularly large decline amongst young adults aged 25-39 (from 19.5% to 16.6%).





Most growth since 2001 has been in the oldest age groups, the 65 and over's increased by 18.4%. There was also an increase in children aged 0-4 years (14.8%).



91.8% of Winchester's resident population are estimated to be of ethnic group 'White British'¹, those in other ethnic groups increased from 5.2% to 8.2% over the period.


Total Dependency has risen due to the increasing numbers of older people and children.

Population Density

There are 1.8 people per hectare living in Winchester. This is below both the South East and England and Wales population densities of 4.5 and 3.7 respectively.



Marital and Civil Partnership Status




52.5% of the adult³ population are married, a decline from 54.8% in 2001. Those that are single (never married) account for 30.0%, an increase from 28.0% in 2001.

Christianity remains the largest religion in Winchester at 63.2% however it has experienced a large decline since 2001. The percentage with no religion has increased by 71.5%.



Households comprised of married or civil partners account for 39.8%. One person households account for 27.4%, of which almost half (49.1%) are occupied by those aged 65 and over.



Between 2001 and 2011 the percentage of rented households increased, alongside shared and outright ownership. The percentage of households owned with a mortgage or a loan decreased by 13.8% over the period.
