SUMMARY

The National Cycling Network, Route 23 is a cycle route from Reading to Southampton. The section of the route between Junction 9 and Winchester Town centre has been designed and it is hoped to complete the scheme this summer. This cycling route will be signed along the existing footway adjacent to Tesco store in Winnall (known as Black Path) to the Winchester City Council-owned flats in Craddock Close and then utilising existing highway into the Town Centre. Although this route has been used for many years, it is in a poor state of repair and runs across private property under 2 different ownerships (Tesco and Winchester City Council). The County Council has been working with the land owners to secure agreement to undertake works to the path to make it suitable for the cycling route. Hampshire County Council has secured a dedication of land from Tesco, so that the cycle route can be created and maintained in the future. A small section of land that leads to the flats is owned by Winchester City Council (and managed by the Landlord Services Team) and it is this section of land that this decision notice relates

to. The proposal is to dedicate this piece of land, as shown hatched on the attached plan, to Hampshire County Council as public highway.

The section from Winnall to Winchester Town Centre is the first phase of creating NCN 23 through Winchester. Phase 2 from The Weirs to South Winchester Park & Ride is also being worked on and an update report will be taken to Cabinet in July 2011.

DECISION

That the Head of Legal Services be given approval to enter into a dedication agreement with the highway authority to dedicate as public highway the land shown hatched on the plan attached to this decision notice, between the path known as "Black Path" and Craddock Close.

REASON FOR THE DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

The scheme will contribute to the completion of part of a National Cycling Network route through Winchester, and will also improve access for residents of Winnall into the Town Centre. The land has no development potential and will not adversely affect the Council's management of its housing stock in the vicinity.

The proposed dedication will contribute to the Sustainable Community Strategy outcome of a High Quality Environment and Active Communities.

RESOURCE IMPLICATIONS:

The scheme will be wholly funded by Hampshire County Council and has no resource implications for Winchester City Council. It will be maintained in the future by Hampshire County Council as part of the public highway.

The scheme which has been designed includes the addition of street lighting along the path from Easton Lane to the flats.

CONSULTATION UNDERTAKEN ON THE DECISION

Consultation has taken place with Sustrans, County Councillors, City Councillors, the Cycling Working Group (made up of HCC/WCC officers, councillors, and cycling representatives), and the Portfolio Holders for Environment and Transport, and Strategic Housing and Landlord Services.
