#### <u>TOPIC – TRAFFIC REGULATION ORDER – TAXI RANKS – VARIOUS ROADS,</u> WINCHESTER

#### **SUMMARY**

- Requests were received from Hampshire Constabulary and WCC Licensing to introduce additional taxi ranks in Winchester city centre to help alleviate antisocial behaviour and reduce the potential for crime and disorder.
- Four potential sites for additional taxi ranks were established and approved for formal consultation. The proposed sites are in Upper Brook Street, St

Georges Street and two sites in Jewry Street. Plans, Statement of Reasons and the associated Schedule are attached. (Appendix 1)

- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- Formal advertisement of the proposals resulted in two objections (plus an additional solicitor's letter on behalf of an objector) and three letters of support. A summary of this correspondence is attached. (Appendix 3)
- Despite pressure from WCC Licensing to introduce all four bays, as a result of the above objections and following discussions and correspondence with Members, it is recommended not to proceed with the introduction of the taxi rank adjacent to 12-13 Jewry Street. (Appendix 1 - Drawing No. 810402/235/002)
- Subject to approval and implementation of the proposal as recommended the impact of the new restrictions will be monitored and possible additional sites for new taxi ranks may be investigated and pursued as part of a new TRO scheme.
- Copy of revised Schedule is attached. (Appendix 4)

#### PROPOSED DECISION

- 1. It is recommended to introduce 'No Stopping (Except Taxis 7pm to 6am)' restrictions in Upper Brook Street, St Georges Street and Jewry Street, Winchester as detailed in the revised schedule attached. (Appendix 4)
- 2. That the Head of Legal Services be authorised to make the necessary order.
