## PROPOSED INDIVIDUAL DECISION BY THE PORTFOLIO HOLDER FOR BUILT ENVIRONMENT

## TOPIC – 20 MILES PER HOUR SPEED LIMIT, WINNALL

## **PROCEDURAL INFORMATION**

## **SUMMARY**

- New regulations from the Department for Transport have meant that is now easier to implement 20mph speed limits in residential areas. Hampshire County Council had chosen 10 areas around the county to be pilot schemes for these new speed limits.
- In addition to the pilot schemes, Hampshire County Council's Executive Member for Environment & Transport on 23 July 2013 agreed to allow the City Council under its Traffic Management Agency arrangements to progress an area wide 20mph speed limit for Winnall.

- The 20mph speed limit proposal for Winnall was advertised for public comment in October and November 2013.
- The proposal is in keeping with the Sustainable Community Strategy. The proposal contributes to the High Quality Environment outcome and those objectives by reducing speeds to encourage the use of walking and cycling as transport modes in Winnall and improving the 'place' that is enjoyed by the residents.
- No letters of objections were received to the proposals.
- The cost of the proposal will be mainly funded through the Winchester Town Account, with additional funding from the Traffic Management Agency Agreement with Hampshire County Council.
- A copy of the plan showing the area covered by the proposed order is attached (Appendix 1).
- A copy of the statement of reasons and list of roads to be covered by the proposed is attached (Appendix 2).
- A copy of the proposal notice is attached (Appendix 3).
- A copy of the advertised order is attached (Appendix 4).

## PROPOSED DECISION

That the 20 miles per hour speed limit be introduced in Winnall (covering those roads as detailed in advertised order attached as Appendix 4 to the Decision Notice) and the Head of Legal and Democratic Services be authorised to make the necessary order.

## REASON FOR THE **PROPOSED** DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

No objections were received for the speed limit order. The proposals did not, therefore, needed to be decided by committee. The reasons for making the order, as set out in the Statement of Reasons in Appendix 2 to this Decision Notice, remain.

## **RESOURCE IMPLICATIONS:**

The advertising and implementation of these traffic regulation orders, forecast to cost  $\pounds 2,000$ , will be covered by the Town Account as part of its approved 2013/2014 budget for 20mph schemes of  $\pounds 4,156$ .

The total cost estimate for the scheme is £3,900. The remaining costs of £1,900, needed for 20mph road markings, will be funded by the Traffic Management Agency Agreement with Hampshire County Council.

## CONSULTATION UNDERTAKEN ON THE PROPOSED DECISION

- An informal survey of the residents of Winnall on draft proposals for an area wide 20mph speed limit took place over the December 2012/January 2013, and these results show that the majority of residents who responded are in support of a lower speed limit.
- The scheme was then submitted to the local Ward Members, Portfolio Holder, County Councillor and Police for their approval to proceed formally.
- Proposal notices were placed in the Mid Hants Observer and posted on street accordingly in October/November 2013. (Appendix 3)



## WINCHESTER CITY COUNCIL ROAD TRAFFIC REGULATION ACT 1984

## THE HAMPSHIRE (VARIOUS ROADS, WINNALL, WINCHESTER) (20 MILES PER HOUR SPEED LIMIT) ORDER 2013

Winchester City Council on behalf of Hampshire County Council in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:

1. In this order, and the preamble and schedule hereto :

"the Act" means the Road Traffic Regulation Act 1984; "mph" means miles per hour; and "road" means any length of highway or any other length of road to which the public has access, and includes bridges over which a road passes. "special forces" has the same meaning as defined in The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011

- No person shall drive any vehicle at a speed exceeding twenty (20)mph on any of those road(s) specified in the schedule to this order.
- No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- 4. This order shall come into operation on 2013 and may be cited as "The Hampshire (Various Roads, Winnall, Winchester)(20 Miles per Hour Speed Limit) Order 2013."
