SUMMARY

- In response to requests from residents and local Members regarding problems
 with parking provision following the introduction of residents permit parking in
 lower Stanmore, it was proposed to revise the restrictions in the existing parking
 bays in Stanmore Lane, Winchester from '2 hour limited waiting 8:00am to
 6:00pm Monday to Saturday' to '2 hour limited waiting 10:00am to 4:00pm
 Monday to Friday' thereby increasing the availability of these bays for residents.
- The proposed changes were advertised on 11th December 2013. Notices were
 posted on street in the immediate vicinity of the proposed changes, published in
 the Mid Hants Observer, placed on the Council's website and held on deposit in
 the City Office reception. No responses were received.

- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no discernable additional enforcement costs.

- No discernable increase in enforcement resources or costs is anticipated.


CONSULTATION UNDERTAKEN ON THE PROPOSED DECISION






EXISTING PARKING BAY RESTRICTIONS - 2 HOURS LIMITED WAITING MON-SAT 8AM-6PM

THE HAMPSHIRE (VARIOUS ROADS WINCHESTER) (PARKING PLACES AND RESTRICTION OF WAITING) (CONTROLLED ZONE) (NO.2) ORDER (VARIATION No.3) 2013

Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers under sections under Sections 1,2 4,32,35,45,46,49,51 and 53 of the Road Traffic Regulation Act 1984 ("the Act"), as amended by the Road Traffic Regulation (Parking) Act 1986, Part IV of Schedule 9 to the Act , and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-

- 1. In this order the "Principal Order " means The Hampshire (Various Road Winchester) (Parking Places And Restriction Of Waiting) (Controlled Zone) (No.2) Order 2012 as amended.
- 2. The Principal Order shall have effect in that the items tabulated in Schedule 1 of this Order shall be removed from Schedule 1 Part 4 of the Principal Order.
- 3. The Principal Order shall have effect in that the items tabulated in Schedule 2 of this Order shall be inserted into the Principal Order as Schedule 1 Part 7.
- 4. This order may be cited as The Hampshire (Various Roads Winchester) (Parking Places And Restriction Of Waiting) (Controlled Zone) (No.2) Order (Variation No.3) 2013 and shall come into operation on the day of 2014.
