SUMMARY

- Following instructions from WCC Housing revisions to the car parking at Greyfriars, Eastgate Street, Winchester were carried out. To prevent nonresidents from parking in the new car park 'permit holders only 8:00am to 10:00pm Monday to Saturday' restrictions were requested to be introduced as well as making the disabled bays enforceable for blue badge holders only.
- The proposed changes were advertised on 18th December 2013. Notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the City Office reception. No responses were received.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.

- The cost of implementing the proposal is funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no discernable additional enforcement costs.
- Copy of the plan showing the location and extent of the proposal is attached (Appendix 1).
- Copy of proposed schedule and statement of reasons is attached (Appendix 2).
- Copy of the proposal notice is attached (Appendix 3).
- Copy of the advertised order is attached (Appendix 4).

DECISION

- It is recommended to introduce restrictions as detailed in the schedule attached (Appendix 2).
- That the Head of Legal and Democratic Services be authorised to make the necessary order.


