SUMMARY

- Following meetings with the local Members, residents and businesses proposals to introduce changes to the waiting restrictions in Hyde Street and other nearby roads were drawn up in response to requests to address parking problems in Hyde Street adjacent to The Mucky Duck as well as requests for additional residents permit holder parking spaces.
- The proposals include:-
 - The extension of the 'no waiting at any time' restrictions between North Walls and Marston Gate to resolve access issues currently being experienced outside the hours of the existing single yellow line restrictions.
 - Extending the parking bay in Hyde Street adjacent to Sarson Press and amending the restriction times to '1 hour limited waiting 8am to 6pm and

permit holders only 6pm to 10pm' to accommodate the needs of local businesses whilst safeguarding parking for residents in the evening.

- The introduction of new areas of 'permit holders only 8am to 10pm' parking bays in Hyde Street, Hyde Gate and King Alfred Place.
- The proposed changes were advertised on 15th July 2015. Notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the City Office reception. Ten responses were received, eight in support of the proposals and two from local organisations seeking information about the consultation process and clarification of the impact on their specific parking needs.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded through the Traffic Management Agency Agreement with Hampshire County Council. There are not expected to be any additional enforcement requirements and therefore no additional resource implications.
- Copy of the plans showing the location and extent of the proposals are attached (Appendix 1).
- Copy of proposed schedule and statement of reasons is attached (Appendix 2).
- Copy of the proposal notice is attached (Appendix 3).
- Copy of the advertised order is attached (Appendix 4).

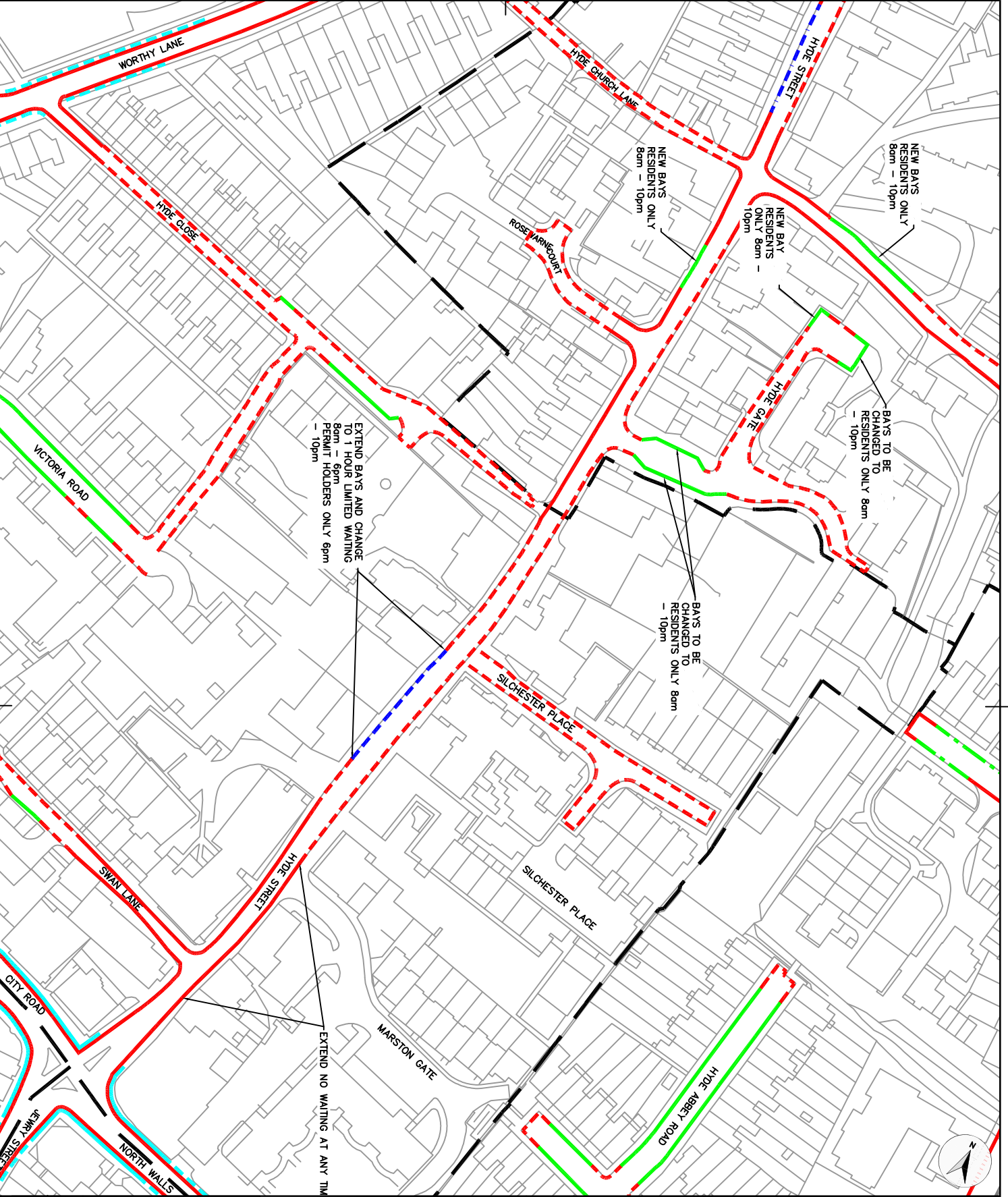

STATEMENT OF REASONS FOR REVISION:-

The proposals are to address issues of visibility, obstruction and/or to increase on-street parking provision. There is significant pressure for on-street parking, consequently the extension of the residents permit parking and limited waiting restrictions should help diffuse the existing parking and access problems which are exacerbated by motorists parking in considerably on single yellow lines, especially on Sundays, due to the lack of formal parking bays.

Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers under sections under Sections 1,2 4,32,35,45,46,49,51 and 53 of the Road Traffic Regulation Act 1984 (" the Act"), as amended by the Road Traffic Regulation (Parking) Act 1986, Part IV of Schedule 9 to the Act , and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order :-

1. In this order the "Principal Order " means "The Hampshire (Various Roads Winchester) (Parking Places And Restriction Of Waiting) (Controlled Zone) (Consolidation) Order 2010 as amended.

2. The Principal Order shall have effect in that the items tabulated in Schedule 1 of this Order shall be removed from the Schedules specified of the Principal Order and the items tabulated in Schedule 2 to this order shall be inserted into the Schedules specified of the Principal Order
