PROPOSED INDIVIDUAL DECISION BY THE PORTFOLIO HOLDER FOR ENVIRONMENT

<u>TOPIC – TRAFFIC REGULATION ORDER – NORTH WEEKE AREA, WINCHESTER</u>

PROCEDURAL INFORMATION

The Access to Information Procedure Rules – Part 4, Section 22 of the Council's Constitution provides for a decision to be made by an individual member of Cabinet.

SUMMARY

- Due to access and obstruction issues for residents and buses caused by inconsiderate commuter parking in some roads in the north Weeke area of Winchester, waiting and parking restrictions are being proposed to control parking to ensure clear access is maintained.
- Informal consultation carried out with all residents established that the majority were supportive of having restrictions introduced.
- The results of the informal consultation were discussed with the three local Ward Members and a draft scheme produced covering all of the roads in the

area to pre-empt the likelihood of further displaced parking if only some roads were covered by restrictions.

- The proposed changes were subsequently formally advertised on 22nd November 2017. Notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the city Office reception. In additional to this nearly 500 letters were sent to all residents in the area notifying them that the proposal was being advertised together with information of how to view the full details.
- 17 responses were received to the formal consultation 4 comments /
 enquiries seeking clarification, 1 in support of the proposals, 5 objections
 which will be resolved by the proposed withdrawal of restrictions for Halls
 Farm Close leaving 7 unresolved objections. A summary of the responses is
 attached (Appendix 1).
- Due to the number of objections from residents of Halls Farm Close it is recommended to withdraw this area from the proposal. It is possible to review this if problems are encountered once restrictions are introduced in the other roads locally. Residents of Halls Farm Close will be notified of this decision and the effect of the new restrictions, if implemented, will be monitored accordingly.
- In addition to the above, four minor changes to the extent of the proposed restrictions are being recommended to address concerns regarding access to properties and to provide more flexibility to residents of Pemerton Road following the removal of the Housing Estate Improvement Scheme for the construction of additional parking. These changes are within the scope of the proposal as advertised and have no detrimental impact or more onerous effect. These changes are covered in the revised proposal plan and schedule attached (Appendix 4 and 5).
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded through the Traffic
 Management Agency Agreement with Hampshire County Council. There may
 be very minimal additional enforcement resource implications, which should
 be covered by the additional permit fee income.
- Copy of the plan showing the location and extent of the proposal as advertised is attached (Appendix 2).
- Copy of the schedule and statement of reasons as advertised is attached (Appendix 3).

RESOURCE IMPLICATIONS:

- The cost of advertising and implementing the traffic regulation order is covered by the Traffic Management Agency Agreement with Hampshire County Council.
- There is unlikely to be any discernible increase in enforcement resources or costs, however any minor increases should be covered by the additional income from permit fees.

CONSULTATION UNDERTAKEN ON THE **PROPOSED** DECISION

- Informal consultation was carried with all residents of the north Weeke area to establish whether restrictions were supported and if so what kind and their extent. The results of this exercise were discussed with the local Councillors and a draft proposal formulated accordingly and circulated for approval.
- Following support for the draft proposal requests for consent to proceed to formal advertisement were sent to all local Ward Members, County Councillor, Police and Parking Office Manager and duly confirmed.
- Proposal notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the City Office reception. In addition to this all residents in the north Weeke area were written to directly to notify them of the proposal.



Halls Farm Close	Objection	Parking by people not resident or without related business to Halls Farm Close has never been a problem and that to impose restrictions fixes a problem that does not exist.	Objection noted. It is suggested to withdraw Halls Farm Close form the proposal. It is possible to monitor the effect of the restrictions if implemented and review this with residents at a later date.
Address not provided	Objection	As a non-resident of Weeke who visits friends in the area on a regularly with a young family I wish to object to the proposals as the two hour limit is too restrictive. A 4 hour limit would be better. There should also be some areas with unlimited parking available to non-residents.	4 hour limited waiting will be very difficult to enforce and will not necessairly stop the reported issue of student parking and would only encourage more vehicle movements with motorists moving their cars after 4 hours from on road to another to avoid getting a pemalty charge notice.
Fleming Road	Objection	The permit proposal will bring unecessary costs with no added value to the street and brings an element of unfriendliness to family and friends who may wish to visit. However there are aeras at junctions and bends which will benefit from having restrictions to prevent inconsiderate parking. Extending permit parking zones makes it harder for residents to receive visiotrs, deliveries, etc. The scheme appears to solve a problem which does not exist and could be taken as a revenue raising opportunity instead of addressing the needs of the community.	The scheme has been designed with a 2 hour limited waiting window to provide as much flexibility for residents and their visiotrs as possible whilst still ensuring the restrictions can be effectively enforced. The restrictions will have no impact on deliveries, if anything they will make access easier by removing all day commuter parking.

Noted. However, it is suggested to withdraw Halls Farm Close form the proposal. It is possible to monitor the effect of the restrcitions if implemented and review this with residents at a later date.


