TOPIC – TRAFFIC REGULATION ORDER PROGRAMME 2018-19

SUMMARY

The Engineering and Transport Team are responsible for introducing new Traffic Regulation Orders (TRO). Each year the Council receives more requests for new TROs than it can implement and consequently a programme is produced to prioritise resources accordingly.

This decision notice summarises the existing TRO requests on file and recommends the TRO programme for 2018/19.

PROPOSED DECISION

That the draft Traffic Regulation Order Programme 2018/19 be formally approved and that delegated authority be given to the Corporate Head of Regulatory to revise the programme with the agreement of the Portfolio Holder for Environment.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Traffic Regulation Orders (TROs) form part of the work covered by the Engineering and Transport Team (Regulatory) and are carried out by the City Council by means of an agency agreement with Hampshire County Council. Due to staffing and financial resource constraints it is not possible to action all the requests received for amending existing or implementing new TROs. All such requests are therefore recorded and prioritised against criteria primarily relating to road safety, community support and impact.

TRO programmes have been produced every year since 2010/11 and have proved an effective and transparent way of prioritising schemes and maximising the use of resources available as well as managing the expectations of those making the requests for action to be taken. Following on from this all outstanding TRO requests currently with the Council have again been reviewed against the relevant criteria as noted on the draft programme for 2018/2019. See Appendix A

Delivering the TRO programme aligns with the Council Strategy in relation to the improving the quality of the district's environment.

RESOURCE IMPLICATIONS:

Hampshire County Council has reduced the budget available for TRO's from £36,500 to £21,900 in 2017/18 and £14,600 in 2018/19. It has been proposed (CAB2873 refers) that, despite not being the responsible authority, WCC will make up the shortfall from £14,600 up to a maximum of £21,900 (£7,300) because £14,600 is not deemed sufficient to meet the service requirements.

The various costs of preparation, advertising and physical introduction of TROs will therefore be covered by:

- a) budget provided by Hampshire County Council to cover TROs implemented under the Traffic Management Agency Agreement (allocation for 2018/19 = £14 600), or
- b) budget provided by Winchester City Council to cover TROs implemented under the Traffic Management Agency Agreement (allocation for 2018/19 = £21 900).
- c) developer funded where changes to a TRO are necessary as part of a planning permission (no budget implications as contribution covers all costs).
