INDIVIDUAL DECISION BY THE PORTFOLIO HOLDER FOR ENVIRONMENT

TOPIC – TRAFFIC REGULATION ORDER – ALRESFORD ROAD AND MAGDALEN HILL, WINCHESTER

PROCEDURAL INFORMATION

The Access to Information Procedure Rules – Part 4, Section 22 of the Council's Constitution provides for a decision to be made by an individual member of Cabinet.

In accordance with the Procedure Rules, the Legal Services Manager, the Chief Executive and the Strategic Director: Resources are consulted together with Chairman and Vice Chairman of The Overview and Scrutiny Committee and any other relevant overview and scrutiny committee. In addition, all Members are notified.

If five or more Members from those informed so request, the Leader may require the matter to be referred to Cabinet for determination.

SUMMARY

- There are three separate areas of changes being taken forward in Alresford Road/Magdalen Hill, Winchester to address concerns raised by residents and local Councillors regarding inconsiderate/inappropriate parking resulting in potential obstructions or reducing visibility.
- Magdalen Hill/Alresford Road – bend
- Parking on the single yellow lines outside the hours of the existing restrictions can cause issues with vehicles being on the 'wrong' side of the road as they negotiate the bend with potential safety issues. It is therefore proposed to extend the 'no waiting at any time' double yellow line restrictions to provide additional lengths of road where parking would not take place.
- Alresford Road – junction with St Johns Road

- Vehicles parking too close to the junction with St Johns Road outside the hours of the existing single yellow line restrictions cause restricted visibility for drivers exiting onto Alresford Road and it is therefore proposed to introduce sections of 'no waiting at any time' double yellow line restrictions on either side of the entrance to ensure visibility sightlines are maintained.
- Alresford Road – access to garages
- Vehicles parking in the immediate vicinity of the garage access on the single yellow lines outside the hours of the existing restrictions are causing reduced visibility for drivers exiting onto Alresford Road and it is therefore proposed to change the existing single yellow line restrictions to 'no waiting at any time' double yellow line restrictions.
- These restrictions would not only keep the area clear and improve visibility for residents exiting the garage access, they would also ensure a clear area is maintained for vehicles using Alresford Road to pull in to allow opposing traffic to pass safely and thereby help maintain the flow of traffic.
- Informal consultation carried out on all three of the above changes with residents in the vicinity of the respective proposals and it was established that there was sufficient support for the changes to the restrictions to be introduced.
- The result of the informal consultation was discussed with the local Ward Members and it was agreed to proceed formally.
- The proposed changes were subsequently formally advertised on 22nd November 2017. Notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the city Office reception. In addition to this were sent to all residents in the immediate vicinity notifying them that the proposal was being advertised together with information of how to view the full details.
- Only 1 response was received to the formal consultation regarding the proposed changes at the garage entrance stating that parking wasn't the main issue in Alresford Road, but that the volume and speed of cars was of far more concern. (Appendix 1) This has been noted, however the proposed changes are considered to be of benefit to residents and road users as a whole and it is recommended that they be introduced accordingly.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no additional enforcement resource implications.

DECISION

- That restrictions be introduced as detailed in the schedule attached (Appendix 3).
- That the Legal Services Manager be authorised to make the necessary order.

RESOURCE IMPLICATIONS:

- The cost of advertising and implementing the traffic regulation order is covered by the Traffic Management Agency Agreement with Hampshire County Council.
- There will be no increase in enforcement resources or costs.

CONSULTATION UNDERTAKEN ON THE DECISION

- Informal consultation was carried with residents in the vicinity of the proposed changes. The results of this exercise were discussed with the local Councillors and a draft proposal formulated accordingly and circulated for approval.
- Following support for the draft proposal requests for consent to proceed to formal advertisement were sent to all local Ward Members, County Councillor, Police and Parking Office Manager and duly confirmed.
- Proposal notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the City Office reception. In addition to this all residents in the vicinity of the changes were written to directly to notify them of the proposal.

I am writing to you regarding the waiting restrictions discussed in the letter you sent on 22nd November.

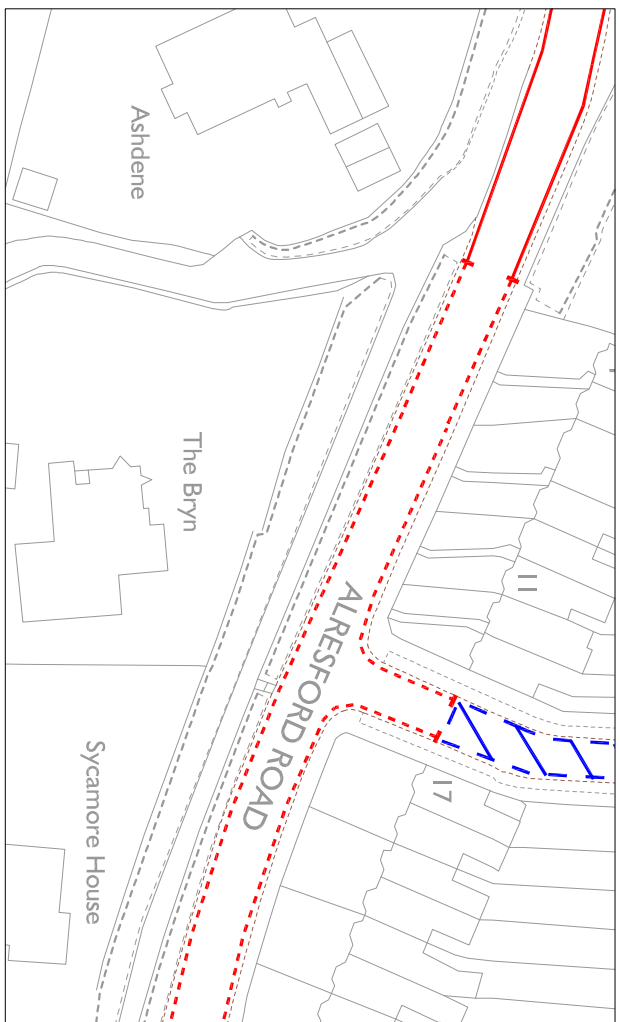
I live at Alresford Road and seriously believe that the waiting restrictions are not the main problem. The main problem is the fast moving 2 way traffic. Since living here I am forever being woken up and disturbed by road rage, bleeping horns and swearing from the drivers that have lost their patience with waiting on that road. If you introduce further waiting restrictions you are not solving the problem of the traffic congestion.

This road needs traffic lights from the golden lion pub to the other side of Quarry Road. This would reduce the accidents and congestion as no one would need to stop or wait for the other cars.

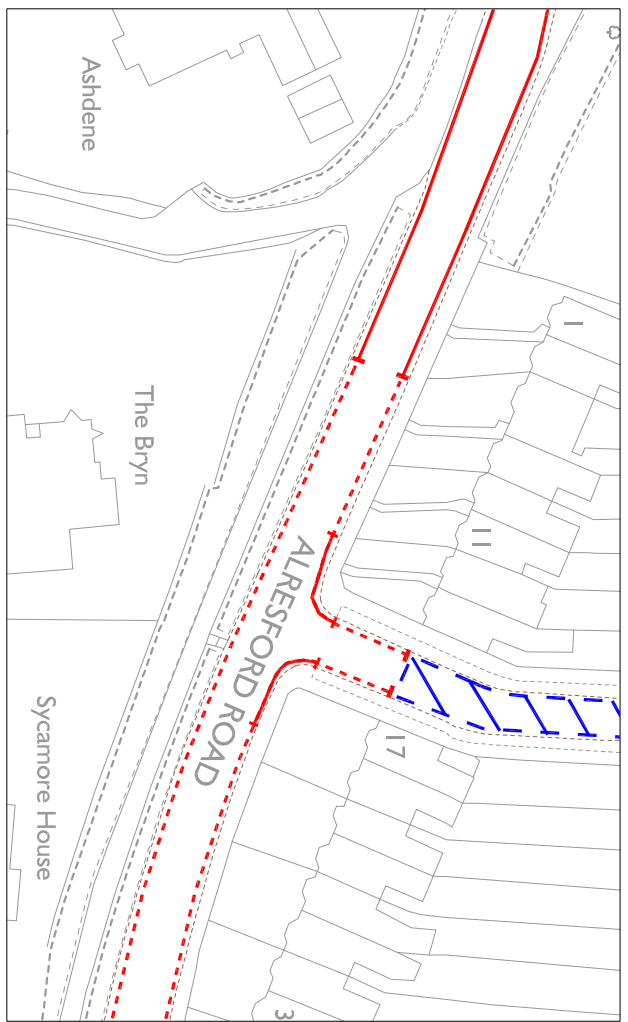
I have personally been forced to reverse down Alresford road by a lorry and 2 cars on 3 separate occasions because they continued to drive towards me, not letting me pull into a space. I am fed up with the abusive nature of the drivers, the constant shouting, damage to vehicles, I have had to mount the curb to prevent an accident with drivers flying up the road at me, not willing to wait. I have assisted in helping 2 accidents on this road, witnessed one more, and had damage to my vehicle from another RTA.

With regards to the waiting restrictions, I can appreciate double yellow lines on the corners of the roads and the corner of the garage access but no further waiting restrictions are necessary.

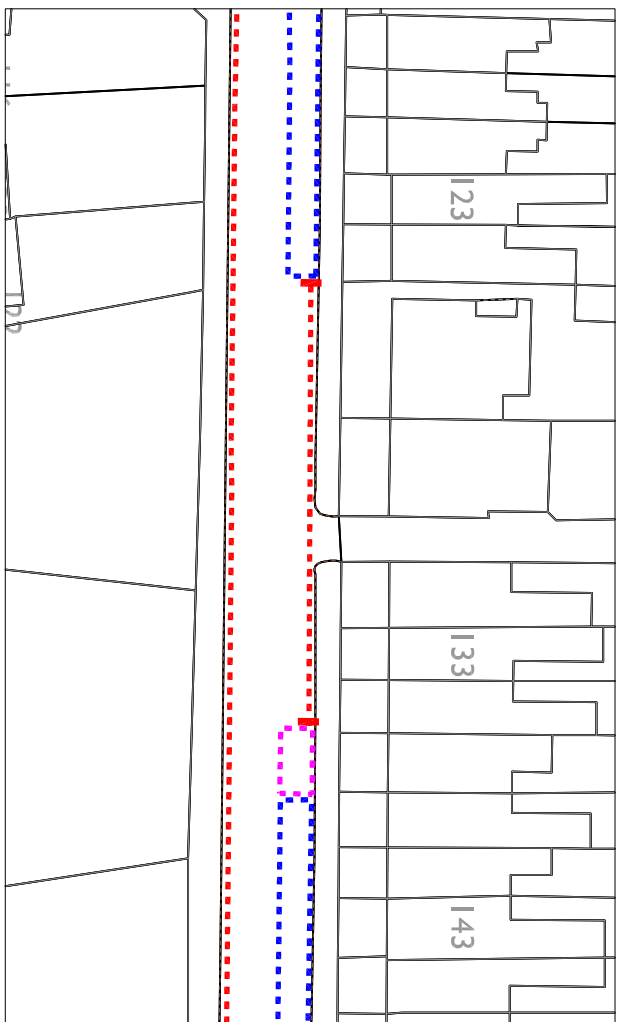


EXISTING WAITING RESTRICTIONS

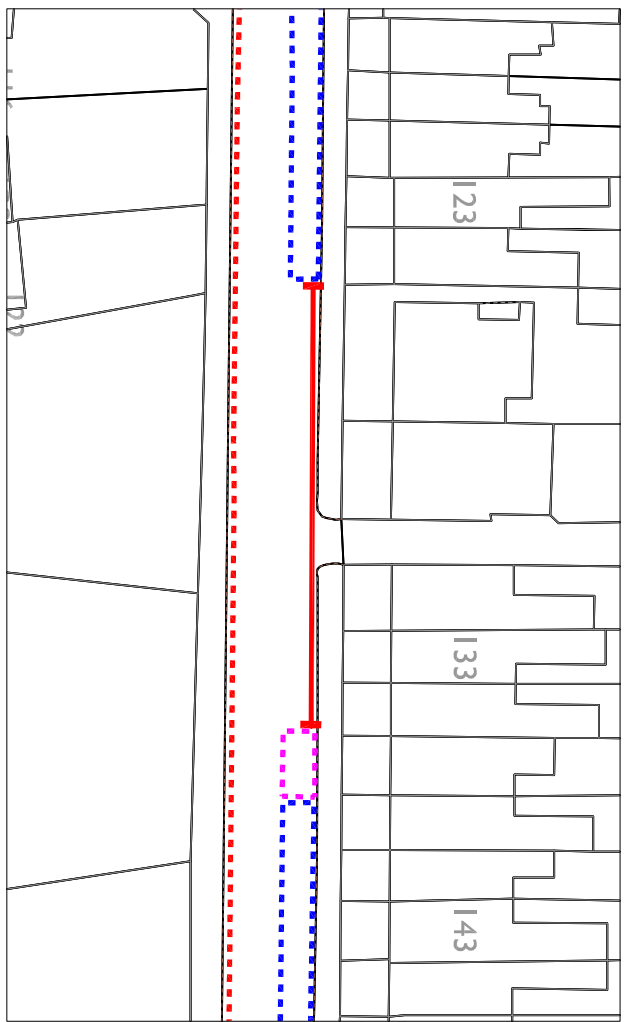

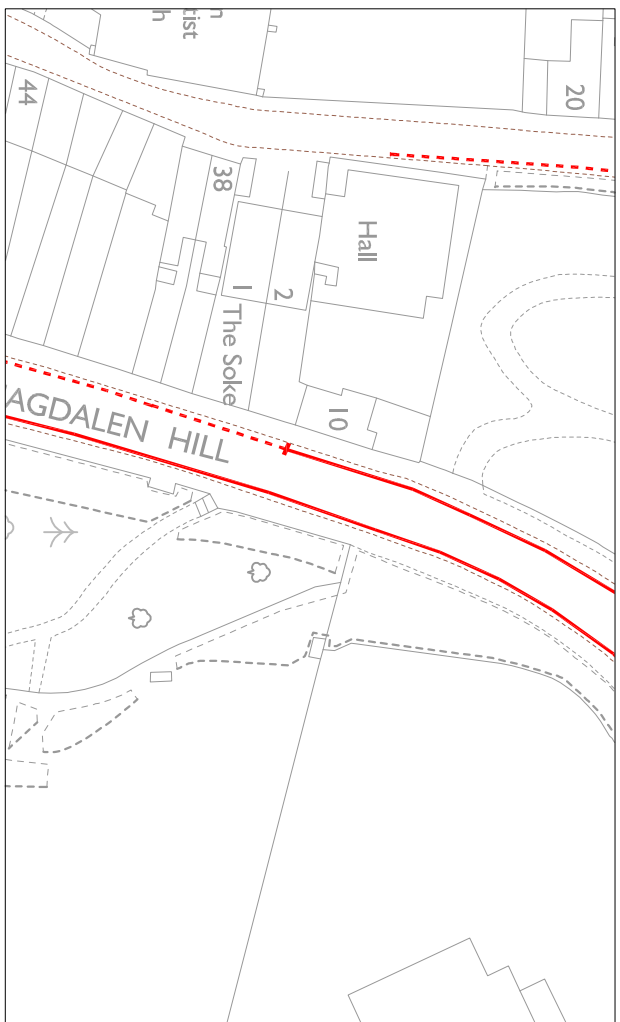

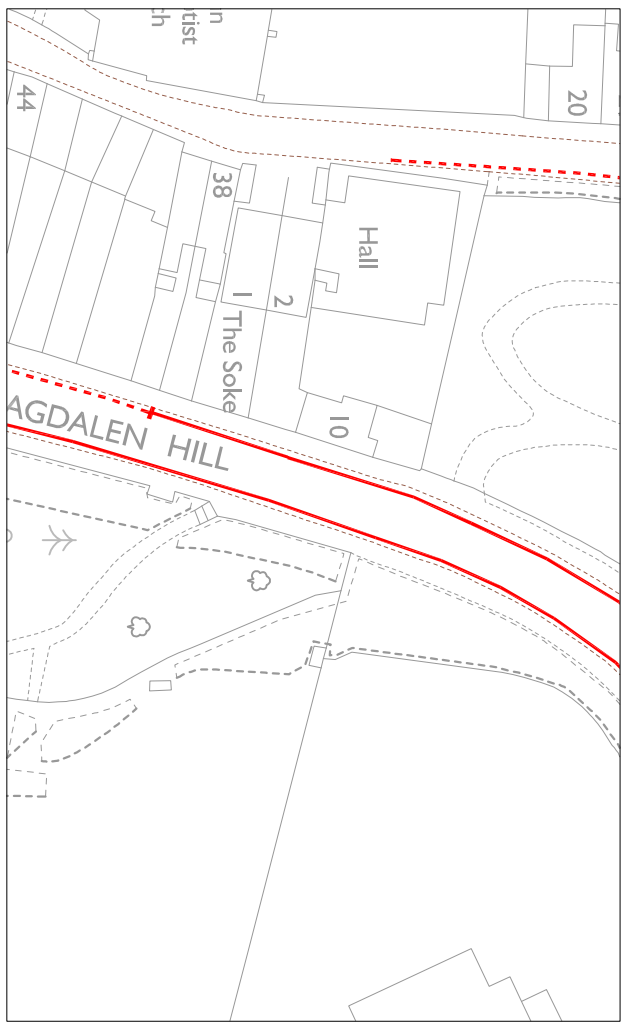
