### TOPIC - PARK & RIDE OUT OF HOURS CLOSURE ORDER

### PROCEDURAL INFORMATION

The Access to Information Procedure Rules – Part 4, Section 22 of the Council's Constitution provides for a decision to be made by an individual member of Cabinet.

In accordance with the Procedure Rules, the Legal Services Manager, the Chief Executive and the Strategic Director: Resources are consulted together with Chairman and Vice Chairman of The Overview and Scrutiny Committee and any other relevant overview and scrutiny committee. In addition, all Members are notified.

If five or more Members from those informed so request, the Leader may require the matter to be referred to Cabinet for determination.

### SUMMARY

- A traffic regulation order was advertised on 20<sup>th</sup> June 2018 to modify the Off-Street Parking Places Order for the City Council's Park and Ride car parks.
- The order was advertised on site, in the Mid-Hants observer and on the City Council's website.
- No responses were received to the advert.
- Currently, these car parks are accessible at all times of the day and night, however vehicles are not permitted to park overnight. The buses run from approximately 6.30am to their last drop off just before 8pm on weekdays and to 7pm on Saturdays.
- Recently, the South car park has been the site of anti-social behaviour associated with the use of motorbikes and vehicles in the evenings generally after the park and ride operation has ceased which has resulted in noise and disturbance and has attracted complaints. In order to address this problem it

is proposed that this car park is closed after the P&R operation has stopped for the day (after 8pm).

- It should be noted that whilst this change will allow all of the park and ride sites to be closed at night the Council can use its discretion about which car parks it prevents access to by lowering barriers at the access points. The Closure will be advertised on site. The problem currently only relates to the South car park and so access will be prevented out of hours in this location, The Council has already effected a temporary closure for this car park which is permitted under the existing TRO.
- Barriers are already in situ in three out of the four car parks. They can be
  easily closed after the last bus in order to curtail anti-social behaviour if
  required. Pitt Park & Ride car park does not have a barrier, but temporary
  barriers could be used if needed.
- Small sections of extra fencing are also being erected in part of South Winchester Park & Ride car park in order to prevent access across landscaped areas of the site.
- Park & Ride users, who return to the car parks after the last bus, may find the barriers closed. The out of hour's helpline is available whereby our CCTV staff will be able to help unlock the barriers and release the vehicles (this is similar to the current situation in The Brooks car park).
- The proposals set out in this report would support the following Council Strategy Outcomes:
  - Improving the quality of the District's environment and specifically by working with our partners and using powers available to us, make Winchester a safe and pleasant place to live, work and visit.

#### DECISION

- 1. That the changes to the Park & Ride Off Street Order be made.
- That the Head of Legal Services (Interim) be authorised to make the necessary order.

## REASON FOR THE DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

### **RESOURCE IMPLICATIONS:**

The Special Maintenance team currently open up the amenity buildings every morning, and therefore can open the barriers at the same time. The Civil Enforcement Officers currently close the amenity buildings at night and therefore will be able to close the barriers.

The Special Maintenance team carried out extra fencing work, funded by the car parks maintenance budget.

### **CONSULTATION UNDERTAKEN ON THE DECISION**

- Hampshire County Council, as land owners, were consulted on the proposal.
  They had no objections to the proposal but wanted to clarify that the changes
  are advertised clearly on site and that in adverse weather, with barriers in
  place the winter maintenance precautionary salting vehicles would not be able
  to access the site.
- New signage will be in place to advise customers of the changes. In relation to adverse weather it would seem unlikely that the Park & Ride car parks would need to be closed and therefore access would be available for salting vehicles to come in and any stranded vehicles to exit.
- The County Councillors and local ward members were informed of the proposals before they advertised.

# FURTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED FOLLOWING PUBLICATION OF THE DRAFT PORTFOLIO HOLDER DECISION NOTICE

Three members made comments regarding the proposal, two expressing concerns over the closures and the knock on effect to special events that use the park and ride. It is important to remember that this traffic order will give the authority to the City Council to close any of the park and ride sites overnight if we need to. Currently the focus is on South Winchester P&R and this is the car park which the Parking Team will be closing overnight.

Special events will not be affected by any closures. Those that already use South Winchester car park for cycling events work closely with the Parking Team and will still be able to use the car park.

At Christmas time the Park and Ride buses run later and on a Sunday. Obviously the car park will be left open to accommodate these changes. Other events that want to use the South car park will be accommodated as far as possible by the Parking Team or asked to use one of the other park and ride sites.
