It does not include meetings where the Councillor attended as a Ward Member or Portfolio Holder to make representations, where they deputised for another Councillor, or meetings in the community or of outside bodies with which the Councillor is involved. 2. The majority of formal committees have deputies appointed. On most occasions when a Councillor could not attend a meeting of which he/she was a member, their absence was covered by a deputy.

3. Members also attend other meetings with Council Officers and/or other Members to discuss Council business. These meetings are also not included in the statistics above.
