

**Notice of Making of Various Road Traffic Regulation Orders
Affecting the District of Winchester City Council**

On 12th July 2007 Winchester City Council as agents for Hampshire County Council made the undermentioned road traffic regulation orders:-

1. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) Order 2002 (Variation No.36) Order 2007.

The effect of this order, proposals for which were advertised on 8th March 2007 will be to extend the time of the existing permit holders only parking restrictions in the undermentioned streets from the current 8am to 6pm to 8am until 10pm on Mondays to Saturdays. The proposed order will also introduce Permit Holders only parking bays in St Peter Street. Details are as follows:-

2. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) Order 2002 (Variation No.32) Order 2007.

The effect of this order, proposals for which were advertised on 29th March 2007 is to prohibit vehicles stopping on Taxi Ranks unless they are Licensed Hackney Carriages. Details are as follows:-

3. The Hampshire (Various Roads, Colden Common) (Parking Places and Restriction of Waiting) Order 2006 (Variation No.1) Order 2007.

The effect of this order, proposals for which were advertised on 22nd March 2007 is to vary waiting restrictions in Spring Lane and Frances Copse, Colden Common Hampshire. Details are as follows:-

4. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) Order 2002 (Variation No.23) Order 2007.

The effect of this order, proposals for which were advertised on 25th January 2007 is to introduce permit holders only parking restrictions and to amend the existing waiting restrictions in St Paul's Hill, Winchester. Details are as follows:-

Copies of the orders, maps showing the locations and a statement of reasons for each of the above orders and the orders to be varied may be inspected during usual office hours at the City Offices, Colebrook Street, Winchester.

Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
