

WAITING RESTRICTIONS – WINNALL CLOSE, WINNALL MANOR ROAD AND WINNALL VALLEY ROAD, WINCHESTER,

TAKE NOTICE that on 23rd October 2008 Winchester City Council on behalf of Hampshire County Council made an experimental traffic regulation order as follows :-

EFFECT OF ORDER:

1. To introduce “No waiting at any time” in the following roads:-

IMPLEMENTATION: The Order will come into effect on 10th November 2008.

The Order is to be on an experimental basis for a maximum period of 18 months and the Council will, in due course consider whether the provisions of the Order should continue in force indefinitely.

OBJECTIONS: Within a period of six months from when the experimental Order comes into force or, if the Order is subsequently varied or modified within six months of the date of the

coming into force of such variation or modification any person may object to the making of an order for the purpose of such indefinite continuation.

All objections must be in writing, stating the grounds on which they are made and sent to the undersigned.

FURTHER DETAILS: A copy of this notice, the order, a map showing the location and effect of the order and a statement of reasons may be inspected during usual hours at City Offices, Colebrook Street, Winchester, Hampshire.

TITLE: The order will be known as "The Hampshire (Winnall Close, Winnall Manor Road and Winnall Valley Road, Winchester) (Experimental) Traffic Regulation Order 2008".
