

**Notice of Making of Various Road Traffic Regulation Orders**  
**Affecting the District of Winchester City Council**

On 11<sup>th</sup> August 2009 Winchester City Council as agents for Hampshire County Council made the undermentioned road traffic regulation orders:-

**1. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) Order 2002 (Variation No.50) Order 2009.**

The effect of this order proposals for which were advertised on 2<sup>nd</sup> April 2009 will be to introduce waiting restrictions and permit holder parking in Dawn Gardens. Details are as follows:-

**2. The Hampshire (Various Roads, Kings Worthy) (Parking Places and Restriction of Waiting) Order 2009.**

The effect of this order proposals for which were advertised on 2<sup>nd</sup> April 2009 will be to introduce waiting restrictions in Kings Worthy.

Details are as follows:-

LONDON ROAD	NORTH	FROM A POINT 10.0 METRES EAST OF ITS JUNCTION WITH CHURCH LANE TO A POINT 8.0 METRES WEST OF THAT JUNCTION.
NORTH ROAD	NORTH-WEST	FROM A POINT 10.0 METRES EAST OF ITS JUNCTION WITH EDINBURGH ROAD TO A POINT 20.0 METRES WEST OF THAT JUNCTION.
NORTH ROAD	NORTH-WEST	FROM A POINT 8.5 METRES EAST OF ITS JUNCTION WITH CHURCHILL CLOSE TO A POINT 14.0 METRES WEST OF THAT JUNCTION.

NORTH ROAD	SOUTH-EAST	FROM A POINT 10.0 METRES EAST OF ITS JUNCTION WITH EDINBURGH ROAD TO A POINT 0.5 METRES EAST OF ITS JUNCTION WITH CHURCHILL CLOSE.
SOMERVILLE ROAD	BOTH	FROM ITS JUNCTION WITH NORTH ROAD TO A POINT 10.0 METRES SOUTH OF THAT JUNCTION.

Each of the above orders will come into operation on 14<sup>th</sup> August 2009.

Copies of the orders, maps showing the locations and a statement of reasons for each of the above orders and the orders to be varied may be inspected during usual office hours at the City Offices, Colebrook Street, Winchester.

Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
