

**Notice of Proposals of making of Various Road Traffic Regulation Orders
Affecting the District of Winchester City Council**

Winchester City Council as agents for Hampshire County Council advertised last week proposals with regard to traffic orders in the following roads, there was a printing error and the notice should have stated that these are proposals (the orders have not been made), full details of the proposals are detailed below please send any representations with regard to these proposals to the undersigned by 7th January 2011;

1. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (No. 2) Order 2002 (Variation No. 22) Order 2010.

The effect of this order will be to extend waiting restrictions in Grange Close and Grange Road and introduce no waiting at any time zones. Details are as follows:-
