TEMPORARY ROAD CLOSURE – VARIOUS ROADS - 11/12 NO. 6

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

1. A32 Droxford Road, Wickham between the B2177 Southwick Road and Bishopswood Road.
2. Whaddon Lane, Owslebury between Hurst Lane and High Street.
3. Heathen Street, Durley between Gregory Lane and Stapleford Lane.
4. Sheepwash Lane, Denmead between Furzeley Road and Newlands Lane.
5. B3035 Botley Road, Curdridge between the A334 Station Hill and Readingroom Lane.
6. Horns Hill, Soberton between Chapel Road and Selworth Lane.
7. Wangfield Lane, Durley between Botley Road and Netherhill Lane.
8. Clewers Lane, Waltham Chase between the B2177 Winchester Road and Clewers Hill.
9. Monument Lane, Southwick between Portsdown Hill Road and Ashley Down Lane.

ALTERNATIVE ROUTES:

1. A32 Droxford Road, Wickham – the A32 School Road, the A334 Winchester Road, the B2177 Winchester Road, the B3035 Lower Lane/The Hangers/Corhampton Lane, the A32 Garrison Hill/Wickham Road.
2. Whaddon Lane, Owslebury – Hurst Lane, the B2177 Portsmouth Road, the B3035 Lower Lane, Beeches Hill, Belmore Lane, Longwood Lane.
3. Heathen Street, Durley – Parsonage Lane, Durley Brook Road, Stapleford Lane.
4. Sheepwash Lane, Denmead – Newlands Lane.
5. B3035 Botley Road, Curdridge – the B3035 Botley Road, the B2177 Winchester Road, the A334 Kitnocks Hill.
6. Horns Hill, Soberton – Chapel Road, May Bush Lane, Plough Lane, Webbs Green, Selworth Lane.
7. Wangfield Lane, Durley – the B3035 Botley Road, Calcot Lane, Mill Lane, Netherhill Lane.
8. Clewers Lane, Waltham Chase – the B2177 Winchester Road, Clewers Hill.
9. Monument Lane, Southwick – Portsdown Hill Road, Swivelton Lane, Boarhunt Lane, Ashley Down Lane.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 3rd August 2011 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for a period of approximately 2 weeks.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out.
