

**Notice of Making of Various Road Traffic Regulation Orders**  
**Affecting the District of Winchester City Council**

On 14<sup>th</sup> December 2012 Winchester City Council as agents for Hampshire County Council made the undermentioned road traffic regulation orders:-

**1. The Hampshire (Various Roads Winchester) (Parking Places And Restriction Of Waiting) (Controlled Zone) (Consolidation) Order 2010 (Variation No. 11) Order 2012**

The effect of this order, proposals for which were advertised on 10<sup>th</sup> October 2012 will be to extend permit holder provisions in Upper Brook Street, Winchester. Details are as follows:-

The effect of this order, proposals for which were advertised on 10<sup>th</sup> October 2012 will be to extend permit holder provisions in St. Catherine's Road and to remove items from the consolidation order included in error. Details are as follows:-

The effect of this order, proposals for which were advertised on 10<sup>th</sup> October 2012 will be to extend no waiting provisions and introduce permit holder provisions in Colebrook Street Winchester. Details are as follows:-

The effect of this order, proposals for which were advertised on 10<sup>th</sup> October 2012 will be to extend permit holder provisions in Andover Road Winchester. Details are as follows:-

The effect of this order, proposals for which were advertised on 10<sup>th</sup> October 2012 will be to extend No waiting at any time provisions in Staple Gardens Winchester. Details are as follows:-

The effect of this order, proposals for which were advertised on 19<sup>th</sup> September 2012 will be to introduce further restriction in Stanmore Winchester. Details are as follows:-

**7. The Hampshire (Various Roads, Kings Worthy) (Parking Places and Restriction of Waiting) Order, 2009 (Variation No.1) 2012**

The effect of this order, proposals for which were advertised on 19<sup>th</sup> September 2012 will be to introduce restrictions in Kings Worthy, Winchester. Details are as follows:-

**8. | The Hampshire (Various Roads, Littleton and Harestock) (Parking Places and Restriction of Waiting) Order 2012."**

The effect of this order, proposals for which were advertised on 19<sup>th</sup> September 2012 will be to introduce restrictions in Littleton and Harestock. Details are as follows:-

**9. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (NO.2) Order 2002 (Variation No.32) Order 2012**

The effect of this order, proposals for which were advertised on 2nd May 2012 will be to introduce and extend waiting restrictions in Hillier Way, Winchester. Details are as follows:-

**10. The Winchester City (Off Street) Parking Places Order 2003 (Variation No.6) Order 2012**

The effect of this order, proposals for which were advertised on 2<sup>nd</sup> May 2012 will be to regulate parking restrictions in Hillier Way Surface Car Park, Winchester. Details are as follows:-

Each of the above orders will come into operation on 2<sup>nd</sup> January 2013.

Copies of the orders, maps showing the locations and a statement of reasons for each of the above orders and the orders to be varied may be inspected during usual office hours at the City Offices, Colebrook Street, Winchester.

Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
