TEMPORARY 10 MPH SPEED LIMIT - EASTON LANE, WINCHESTER TEMPORARY 50 MPH SPEED LIMIT – SPITFIRE LINK, WINCHESTER TEMPORARY ROAD CLOSURE - EASTON LANE, WINCHESTER TEMPORARY ROAD CLOSURE – SPITFIRE LINK, WINCHESTER

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council has made an Order on traffic management and road safety grounds to allow for the introduction of a temporary speed limits and road closures in association with highways works as follows:-

ROADS TO BE SUBJECT TO 10 MPH:

EASTON LANE, WINCHESTER northbound between its junction with M3 Junction 9 (Winnall Interchange Roundabout) and a point 150 metres south-west of that point.

ROADS TO BE SUBJECT TO 50 MPH:

SPITFIRE LINK, WINCHESTER between its junction with M3 Junction 9 (Winnall Interchange Roundabout) and a point 150 metres south of that point.

ROADS TO BE CLOSED:

EASTON LANE, WINCHESTER northbound between its junction with M3 Junction 9 (Winnall Interchange roundabout) and a point 100 metres south-west of that point.

ALTERNATIVE ROUTE:

Easton Lane, Wales Street, Durngate, Eastgate Street, Bridge Street, Chesil Street, Bar End Road, A31 Spitfire Link, A33 Spitfire Link.

ROADS TO BE CLOSED:

SPITFIRE LINK, WINCHESTER southbound between its junction with M3 Junction 9 (Winnall Interchange roundabout) and a point 150 metres south of that point.

ALTERNATIVE ROUTE:

Easton Lane, Wales Street, Durngate, Eastgate Street, Bridge Street, Chesil Street, Bar End Road, A31 Spitfire Link, A33 Spitfire Link.

ROADS TO BE CLOSED:

SPITFIRE LINK, WINCHESTER northbound between its junction with M3 Junction 9 (Winnall Interchange roundabout) and a point 150 metres south of that point.

ALTERNATIVE ROUTE:

A33 Spitfire Link, Bar End Road, Chesil Street, Bridge Street, Eastgate Street, Friarsgate, Upper Brook Street, St Georges Street, Jewry Street, North Walls, Durngate, Wales Street, Easton Lane.

ORDERS TO BE SUSPENDED:

None.

PERIOD OF RESTRICTION:

From and including the 28th June 2013 for a period of twelve months or until completion of the works whichever is sooner. (Notwithstanding the above the temporary speed limits and closures are only likely to be for 8 weeks – over night)

Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out.
