TEMPORARY ROAD CLOSURE – VARIOUS ROADS - 13/14 NO. 16

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for highway works to be undertaken as follows:

ROADS TO BE CLOSED:

1. Uplands Road, Denmead – between its junction with Brook Lane and its junction with Hambledon Road.
2. Dirty Lane, Denmead – between its junction with Uplands Road and its junction with Ervills Lane.
3. Upper Crabbick Lane, Denmead - between its junction with Uplands Road and its junction with School Lane.
4. Thompsons Lane, Denmead - between its junction with Uplands Road and its junction with School Lane.
5. Pitymoor Lane, Southwick - between its junction with Southwick Road and its junction with Pigeon House Lane.
6. Pigeon House Lane, Southwick - between its junction with Portsdown Hill and its junction with Pitymoor Lane.
7. Belney Lane, Southwick - between its junction with Pitymoor Lane and its junction with Sheepwash Lane.
8. Potwell Lane, Southwick - between its junction with Pigeon House Lane and its junction with Mill Lane.
9. Widley Walk, Southwick - between its junction with Purbrook Heath Lane and its junction with Portsdown Hill Road.
10. Brook Lane, Hambledon - between its junction with Green Lane and its junction with The Hangers.
11. South Boarhunt Lane, Boarhunt - between its junction with Southwick Road and its junction with Fareham Road.
12. Anmore Lane, Horndean - between its junction with Anmore Road and its junction with Broadway Lane.
13. Frith Lane, Wickham - between its junction with Blind Lane and its junction with Newmans Lane.
14. Blind Lane, Wickham - between its junction with Winchester Road and its junction with Frith lane.
15. Newlands Lane, Denmead - between its junction with Furzeley Road and its junction with Purbrook Heath Road.
16. Purbrook Heath Road, Denmead - between its junction with Newlands Lane and its junction with London Road.
17. Hundred Acres Road, Wickham/Swanmore/Newtown - between its junction with Southwick Road and its junction with Church Road.

ALTERNATIVE ROUTES:

1. Uplands Road, Denmead – Hambledon Road, School Lane, Brook Lane.
2. Dirty Lane, Denmead – Ervills Lane, Forest Road, Inhams Lane, School Lane.
3. Upper Crabbick Lane, Denmead – Uplands Road, Thompsons Lane, School Lane.
4. Thompsons Lane, Denmead – Uplands Road, Upper Crabbick Lane, School Lane.
5. Pitymoor Lane, Southwick – Southwick Road, Portsdown Hill Road, Pigeon House Lane.
6. Pigeon House Lane, Southwick - Pigeon House Lane, Pitymoor Lane, Southwick Road, Portsdown Hill Road.
7. Belney Lane, Southwick – Sheepwash Lane, Newlands Lane, Purbrook Heath Road, Potwell Lane, Pigeon House Lane.
8. Potwell Lane, Southwick – Pigeon House Lane, Portsdown Hill Road, Mill Lane.
9. Widley Walk, Southwick – Purbrook Heath Road, Mill Lane, Portsdown Hill Road.
10. Brook Lane, Hambledon – The Hangers, East Street, West Street, Green Lane.
11. South Boarhunt Lane, Boarhunt – Southwick Road, Ham Lane.
12. Anmore Lane, Horndean – Anmore Road, Mill Road, Hambledon Road, Milton Road, Lovedean Lane, Day Lane.
13. Frith Lane, Wickham – Blind Lane, Pricketts Hill, High Street, Twynhams Hill, Hospital Road.
14. Blind Lane, Wickham – Winchester Road, Buddens Road, Station Road, Mill Lane.
15. Newlands Lane, Denmead – Furzeley Road, Forest Road, Hambledon Road, Maurepas Way, London Road, Purbrook Heath Road.
16. Purbrook Heath Road, Denmead – Newlands Lane, Furzeley Road, Forest Road, Hambledon Road, Maurepas Way, London Road.
17. Hundred Acres Road, Wickham/Swanmore/Newtown – Southwick Road, Droxford Road, Stoneover Road, Heath Road, Liberty Road, Church Road.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 4th November 2013 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
