



TRAFFIC REGULATION ORDER

Notice of Making of Various Road Traffic Regulation Orders Affecting the District of Winchester City Council

On 18th August 2014 Winchester City Council as agents for Hampshire County Council made the undermentioned road traffic regulation orders:-

1. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) (No.2) Order 2012 (Variation No. 6) Order 2014

The effect of this order, will be to introduce no waiting zones in Stanmore Lane and Queens Mead and limited waiting in Westminster Gate, details are as follows;

No Waiting 8am to 9am and 3pm to 4pm Monday to Friday

WESTMINSTER GATE	NORTH	BETWEEN A POINT 4.7 METRES WEST OF ITS JUNCTION WITH OLIVERS BATTERY ROAD NORTH AND A POINT 91.0 METRES WEST OF THAT JUNCTION.	*
WESTMINSTER GATE	SOUTH	BETWEEN A POINT 4.7 METRES WEST OF ITS JUNCTION WITH OLIVERS BATTERY ROAD NORTH AND A POINT 68.0 METRES WEST OF THAT JUNCTION.	*
WESTMINSTER GATE	SOUTH	BETWEEN A POINT 75.0 METRES WEST OF ITS JUNCTION WITH OLIVERS BATTERY ROAD NORTH AND A POINT 91.0 METRES WEST OF THAT JUNCTION.	*

The order will come into operation on the 1st September 2014.

Copies of the order, together with plans defining the permit zones for Stanmore Winchester can be inspected at City Offices Colebrook Street, Winchester.

Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
