TEMPORARY ROAD CLOSURE – VARIOUS ROADS – 15/16 NO. 26

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for highway works to be undertaken as follows:

ROADS TO BE CLOSED:

1. Millers Lane, Olivers Battery – between its junction with Old Kennels Lane and its junction with the A3090 Romsey Road.
2. Old Kennels Lane, Olivers Battery – between its junction with Olivers Battery Road South and its junction with Port Lane.
3. Mount View Road, Olivers Battery – for its entire length.
4. Farley Close, Olivers Battery – for its entire length.
5. Braeside Close, Olivers Battery – for its entire length.
6. Treble Close, Olivers Battery – for its entire length.
7. Momford Road, Olivers Battery – for its entire length.
8. Sunnydown Road, Olivers Battery – for its entire length.
9. Broad View Lane, Olivers Battery – for its entire length.
10. Pine Close, Olivers Battery – for its entire length.
11. Beech Close, Olivers Battery – for its entire length.
12. Wedmore Close, Olivers Battery – for its entire length.
13. Lisle Close, Olivers Battery – for its entire length.
14. Old Kennels Close, Olivers Battery - for its entire length.

ALTERNATIVE ROUTES:

1. Millers Lane, Olivers Battery – Old Kennels Lane, Olivers Battery Road South, A3090 Badger Farm Road, A3090 Romsey Road.
2. Old Kennels Lane, Olivers Battery – Olivers Battery Road South, A3090 Badger Farm Road, A3090 Rosmeay Road, Millers Lane.
3. Mount View Road, Olivers Battery – None.
4. Farley Close, Olivers Battery – None.
5. Braeside Close, Olivers Battery – None.
6. Treble Close, Olivers Battery – None.
7. Momford Road, Olivers Battery – Old kennels Lane, Olivers Battery Road South.
8. Sunnydown Road, Olivers Battery – Old Kennels Lane.
9. Broad View Lane, Olivers Battery – None.
10. Pine Close, Olivers Battery – None.
11. Beech Close, Olivers Battery – None.
12. Wedmore Close, Olivers Battery – None.
13. Lisle Close, Olivers Battery – None.
14. Old Kennels Close, Olivers Battery - None.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 23rd November 2015 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
