### Notice of Proposal of making of Traffic Regulation Order Affecting the District of Winchester City Council

Winchester City Council as agents for Hampshire County Council proposes making the undermentioned road traffic regulation order:-

The Hampshire (Various Roads Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) (Consolidation) Order 2010 (Variation No. 43) Order 2016

The purpose of this order is to extend the no waiting provisions in Hyde Gate and Hyde Street, Winchester. Details are as follows;

HYDE STREET	EAST	BETWEEN A POINT 15.5 METRES NORTH OF ITS JUNCTION WITH KING ALFRED PLACE AND A POINT 20.6 METRES SOUTH OF ITS JUNCTION WITH HYDE GATE.	O	I
HYDE STREET	WEST	BETWEEN A POINT 14.8 METRES NORTH OF ITS JUNCTION WITH HYDE CHURCH LANE AND ITS JUNCTION WITH HYDE CLOSE.	O	I
