TRAFFIC REGULATION ORDER

Notice of making of Road Traffic Regulation Order
Affecting the District of Winchester City Council

On 26th September 2016 Winchester City Council and Winchester City Council acting as agents for Hampshire County Council made the undermentioned road traffic regulation order:-

The Hampshire (Various Roads Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) (Consolidation) Order 2010 (Variation No. 36) Order 2016

The effect of this order proposals for which were advertised on the 18th May 2016 will be to revise waiting restrictions in the Weeke area of Winchester which includes the introduction of permit zones. Details are as follows:-

Copies of the orders, maps showing the locations and a statement of reasons for each of the above orders and the orders to be varied may be inspected during usual office hours at the City Offices, Colebrook Street, Winchester.

Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
