Winchester District Local Plan Part 2 – Development Management and Site Allocations

Adoption Statement

In accordance with the Planning and Compulsory Purchase Act 2004, Regulation 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004, notice is hereby given that Winchester City Council adopted the Winchester District Local Plan Part 2 – Development Management and Site Allocations on 5 April 2017.

The adopted Local Plan Part 2 includes the Main Modifications as recommended by the Inspector who carried out the independent examination of the Plan during 2016. The Main Modifications are set out in the Inspector's report, and these were subject to a six week consultation period during October – December 2016. Local Plan Part 2 covers the administrative area of Winchester District excluding the area of the South Downs National Park Authority that lies within the District, and reflects the development strategy in Local Plan Part 1 adopted in March 2013. Local Plan Part 2 allocates non-strategic sites for development and includes a comprehensive range of development management policies. An application may not be made without the leave of the High Court, and an application for leave must be made (Section 113 (3B)) no later than the end of a period of six weeks from the date of the adoption of this Local Plan Part 2 - Development Management and Site Allocations.
