**NOTICE OF BALLOT**

**Notice is hereby given that :**

1. Winchester City Centre Partnership Ltd is promoting the Business Improvement District (BID) within the central area of Winchester. The map attached indicates the extent of the proposed BID area.
2. A ballot will be held in relation to the proposals developed by the Winchester City Centre Partnership. 3. Voting in the ballot will be by post only.

5. The question to be asked on the ballot paper is :-

8. For the ballot to be successful there must be a simple majority of those voting in favour of the proposal, both in terms of the numbers voting and also the rateable value represented by those voting.
