



NOTICE OF PROPOSED TRAFFIC REGULATION ORDER

THE HAMPSHIRE (VARIOUS ROADS, WINCHESTER) (PARKING PLACES AND RESTRICTION OF WAITING) (CONTROLLED ZONE) (NO. 2) ORDER 2012 (VARIATION NO. 17) ORDER 2019

Winchester City Council as agents for Hampshire County Council gives notice that it proposes to make an Order under the Road Traffic Regulation Act 1984 and all other enabling powers. If the Order comes into force it will introduce the following changes:

1. Sections of The Valley will be changed to 'No Waiting at Any Time' restrictions (double yellow lines) and '2 Hour Limited Waiting with Permit Holders Exemption' parking address issues of visibility and access and to increase on-street parking provision in general and specifically in connection with new developments.
