Public Path Stopping Up No 2 Order 2019**

On 3 March 2020 Winchester City Council confirmed the above Orders without modification.

The effect of the Orders as confirmed is to:

- (1) divert sections of Footpath 507 at Burnet Lane, Kings Worthy running from V1 to V2, V3 to V4 and V5 to V6 respectively and to create new sections of footpath running from V1 to V2 and V3 to V4 respectively as shown on the relevant Order Map;
- (2) divert sections of unrecorded Footpath at Burnet Lane, Kings Worthy running from Y1 to Y2, Y5 to X1 and Y3 to Y4 respectively and create new sections of footpath running from Y1 to Y2, Y3 to Y4, Y4 to Y5 and Y4 to Y6 respectively as shown on the relevant Order Map; and
- (3) stop up a section of unrecorded Footpath at Burnet Lane, Kings Worthy running from W1 to X1 as shown on the relevant Order Map; and
- (4) stop up a section of unrecorded Footpath at Burnet Lane, Kings Worthy running from W2 to X2 as shown on the relevant Order Map.

A copy of the Orders and the Order Maps may be viewed free of charge at Winchester City Council, City Offices, Colebrook Street, Winchester SO23 9LJ from 8.30am to 4.30pm on Mondays to Fridays and on the Council's website: <https://www.winchester.gov.uk/public-notices/>. Copies of the Order and Maps may be bought there at the price of £2.00.

The Orders come into force on 3 March 2020 but if any person aggrieved by any of the Orders desires to question their validity or that of any provision

contained in the Orders on the ground that it is not within the powers of the above Act or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Orders, he or she may apply to the High Court for any of these purposes under section 287 of the Town and Country Planning Act 1990 within 6 weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to that Act.
