Proposal: Remove wooden secondary window casements in basement and introduce open glazed slimline aluminium windows and frames.

To remove the wooden secondary window casements in the basement areas to facilitate the introduction of opening glazed windows within the stone mullions.

The wooden secondary window casements in the basement are not original to the building and covering the inside of the mullions. Through the way it was constructed it lets rain water in and has twice flooded the basement in separate locations and incidents.

Insert heritage slimline aluminium windows and frames in keeping with the building inside the opening of the mullions. (<https://www.smartsystems.co.uk/product/132/alitherm-heritage>). Thus exposing the mullions on the inside of the property and enhancing the original building on the inside. Fitted with slim double glazing in order to avoid damp issues with windows in the basement as well as avoiding the need for secondary glazing.

Through opening up these features we would better reveal the buildings significance.
